Status of U.S. States Voting Rules and Schedule for 2020 Elections

(Updated: July 31st, 2020)

States across the country are preparing for an unprecedented election cycle. Covid-19 has pushed states to consider changes to voting policies like Early Voting, Absentee, and Voteby-Mail. Each state has put together their own schedule for voting this year and we summarize those timelines here.

If hand-delivered, the ballot must be in the office of the Absentee Election Manager by the close of business (but no later than 5 p.m.) on the day prior to the election.

Nov 3 GE: N/A. The state's permanent absentee/mail-in voting procedure is for a request-required absentee/mail-in voting. No excuse is required.

Comments: An early ballot may be requested through the state's new Voter Information Portal or by contacting your County Recorder's office. Arizonans who vote by mail can mail it back or drop it off at any drop-box or voting location in their county. Registered voters have two ways to get a ballot-by-mail: Sign up for the Permanent Early Voting List when you register to vote, or, request a one-time ballot-by-mail.

Changes due to COVID-19:

Nov 3 GE: Gov. Asa Hutchinson (R) and Secretary of State John Thurston (R) announced that voters in the November 3, 2020, general election would be allowed to cite concerns over COVID-19 as a valid excuse for voting absentee.

Comments:

Depending on the type of election being conducted, you may early vote during the 7 or 15 days prior to Election Day. In most counties, early voting is conducted at the county clerk's office. In counties with offsite early voting (a location other than the county clerk's office), local newspapers will publish the designated sites.

The clerk will then issue an absentee ballot to you through the method you selected on the application (in person or by mail, fax is not an accepted method). Complete your ballot and return it to the county clerk as instructed.

The law only specifies a deadline on obtaining absentee ballots by designated bearer. They may pick up your ballot from the county clerk no earlier than 15 days before a preferential or general election and no earlier than 7 days before a runoff and all other elections. You should pick up your ballot based on your ability to deliver it back to the county clerk on time.

Comments:

A voter may choose to return the voted ballot by mailing it to the county elections official, returning it in person to a polling place or to the county elections office, dropping it off into one of the ballot-drop boxes, or authorizing someone to return the ballot on their behalf.

Vote-by-mail ballots that are mailed must be postmarked on or before Election Day and received by the county elections office no later than 17 days after Election Day.

Vote-by-mail ballots that are personally delivered must be delivered no later than the close of polls at 8:00 p.m. on Election Day.

Comments: A request for an absentee ballot must be received by no later than 7 days before the election in which you wish to vote. The voted and mailed ballot must be postmarked or otherwise demonstrated to have been sent on or before Election Day, and must be arrive no later than the 7th day after Election Day.

Comments:

Any voter may vote absentee without excuse or reason. Any voter who wants a vote-by-mail ballot must submit a request to their local election office signed and dated at the proper time in October. Any citizen may also submit a ballot request online. In person voting requires picture and signature verification ID, but absentee and vote by mail ballots only require ID if it is a first-time voter. Ballots that are incomplete are incorrect will be submitted as provisional ballots and the voter's identity will be confirmed subsequently.

Primary:

Mail-in ballot applications were sent automatically to all voters in the primary on June 9th.

Nov 3 GE:

Local counties are now permitted to provide drop-boxes for absentee ballots, instead of requiring voters to mail in their ballots. Counties are also now permitted to process, but not count directly, the result of absentee ballots before Election Day to prepare for an increase in absentee ballot voters in 2020.

Comments:

Voters can request an absentee ballot up to 180 days before the election by visiting their local county office. No ID is required for vote-by-mail, but ID is required for in-person early voting. Neither absentee nor early voting require a reason or excuse in Georgia.

Comments: All properly registered voters will receive a mail ballot packet approximately 18 days prior to the election. Voters may return their ballot by mail or in-person at a designated place of deposit. Voted ballots must be received by the Clerk's Office by 7:00 p.m. on Election Day. There is currently a push from political groups to extend the no excuse vote-by-mail rules that were in place during the June 2nd primary. To vote by mail, voters should contact their county election officer and request an advance ballot application. Advance ballots are mailed to voters starting 20 days before the election. Voters can also hand-deliver their advance ballot to the county election office or any polling location within their county by the close of polls on Election Day.

Ballots cast in this way must be witnessed by either a notary public, a municipal clerk, a Clerk of Courts, or 2 other witnesses.

Changes due to COVID-19:

Primary: Mail-in ballots sent automatically to all voters in the June 2, 2020, primary (at least one in-person voting center open in each county). Mail-in ballots sent automatically to all voters in the April 28, 2020, special election for Maryland's 7th Congressional District (in-person voting available for those unable to vote by mail).

Nov 3 GE: Mail-in ballot applications sent automatically to all voters in the November 3, 2020, general election.

Comments: Ballots are typically mailed or available for download about 3 weeks before an election. To return the absentee ballot in person, it must be delivered to your local board of elections by 8 pm on Election Day, or brought to an early voting center or a polling place by the time the polls close. A mailed voted ballot, must be postmarked on or before general election day and received by the local board of elections by 10 am on November 13, 2020.

Absentee/mail-in voting eligibility extended to all qualified voters in the fall primary and general elections.

Comments: In July, a law was passed to allow all registered voters in Massachusetts to vote by mail in any 2020 election, with no excuse needed. Under this new law, a vote-by-mail application will be mailed to every person who was registered to vote by July 1 and who had not already requested an absentee ballot for the State Primary or for all elections this year. A second mailing will be sent out in September to all voters who have not already applied for a vote-by-mail ballot for the November election. The applications are pre-addressed to your local election official and no postage is necessary.

Comments:

Minnesota waived its witness requirements for absentee ballots for the statewide primary election in August under the settlement of two lawsuits sparked by the health threat from the coronavirus pandemic. If the consent decrees hold, it may be extended for November's general election.

Return your ballot by mail or package delivery service (such as FedEx or UPS). You can also return your ballot in person no later than 3 p.m. on Election Day to the election office that sent your ballot. You can drop off ballots for up to three other voters. You will need to show identification with name and signature when returning a ballot for someone else.

Governor Tate Reeves has stated that he does not see the need to address potential General Election changes at this juncture, meaning in-person voting will still be the primary method for Mississippians to cast their ballots in November unless they qualify for an absentee ballot.

If your absentee ballot is mailed to you, you must return it to the county election board by mail. Ballots delivered by hand must be returned no later than the end of business hours on the day before the election. Only standard absentee ballots may be returned in-person, and the voter must show proper identification. Marci Andino, the executive director of the South Carolina Election Commission, sent the letter to state Sen. Harvey Peeler and South Carolina House Speaker Jay Lucas last Friday, expressing serious concerns about the coronavirus pandemic and its impact to the November elections.

Before the June primaries, the General Assembly passed a bill that allowed qualified voters to vote absentee, but for the June primaries only, and also the opening of absentee ballot return envelopes the day before the election. Andino said the changes and the efforts by voters, poll managers and election officials led to successful primaries, "however, success in June does not necessarily translate to success in November. Voter turnout and absentee voting in a General Election are significantly higher than in primaries," Andino wrote. "Even under normal circumstances, presidential elections are the ultimate test of any state's election process." In the letter, Andino estimates that more than 1.6 million absentee ballots will be cast in November, and if voters choose by mail, more than 1 million of those ballots will be cast by mail. The Election Commission is concerned that the absentee-by-mail process will be overwhelmed and overrun if they have the same rules and provisions in place as the June primaries.

All ballots sent to citizens come with pre-paid postage and can be submitted by mail or by ballot drop boxes across the state. These drop boxes are open until 8 pm on Election Day.
